Students representing East Bernstadt Middle School, Lynn Camp Middle School, North Laurel Middle School, South Laurel Middle School and Knox County Middle School had the opportunity to explore hands-on activities, learn from professional leaders in the community and dream big about their futures.

The purpose of STEM Goes Red is to educate students about the nearly eight million science, technology, engineering and math jobs that are currently available throughout the United States. Not only are American students generally unprepared to fill these roles,



just three in 100 female undergraduate students continue to work in STEM fields after graduating.

Jackson Energy President and CEO Carol Wright participated in a panel discussion. The students heard firsthand of Wright's personal experiences, accomplishments and the challenges she encountered and overcame in the STEM field of engineering.

2020 Census FAQ

What is the census?

The census is a count of every person who lives in the United States and its territories.

What's in it for me?

Your responses inform where over \$675 billion is distributed each year to communities nationwide for clinics, schools, roads and more. Responding also fulfills your civic duty because it's mandated by the U.S. Constitution. The United States has counted its population every 10 years since 1790. Your responses are used to redraw legislative districts and determine the number of seats our state has in the U.S. House of Representatives.

Is my information safe?

Your responses to the 2020 Census are safe, secure and protected by federal law. Your answers can only be used to produce statistics. They cannot be used against you by any government agency or court in any way.

What will I be asked?

You will be asked a few simple questions, like age, sex and the number of people who live in your home. The census will never ask for Social Security numbers, bank or credit card numbers, money or donations or anything related to political parties.

LINEMAN TRAINING CENTER Scholarship Application



Applications must be received at the Jackson Energy office or postmarked by May 22, 2020

Applicants must complete this form to be considered for the scholarship. The scholarship amount will not exceed \$4,200.

1. Applicants must be at least a senior in high school.
2. Applicants shall enroll in the Somerset Lineman Training Center and begin the program by October 2020. The applicant chosen for the scholarship shall also acquire their CDL permit before beginning the program.
3. Applicants, their parents or legal guardians must be a Jackson Energy member with their primary residence or business served by the cooperative.
4. Students who apply for the scholarship will be required to interview with a Selection Committee consisting of Jackson Energy employees.
5. Scholarships will be paid directly to Somerset Community College-Lineman Training Program.
6. Applicants must not be a member of the immediate family of an employee or director of Jackson Energy. Immediate family is defined as a spouse or a child of an employee or director.
7. Applicants shall not be previous winners of the Jackson Energy Scholarship Essay Contest.
8. Entries must be legible. Any entry that is not legible will be disqualified.
